## PROJECT UPDATE:

**Croquet Update:** Downers currently mow the lawns. Downers Construction Insurance has replaced the stolen pump. Mark has contacted Geoff Canham and is meeting with Downers, independent report has been made and also a Downers report. Downers are doing what there report says.

Clarke Street Entrance: Revised plan. Hauraki District Council is checking the new plan details. Tanya has a new contact at Council with Adrian. Requesting a copy of plan from Paul Matthews. Then once the plan has been received Beach Contractors to update the quote.

Waihi Bowling Green: No recent movement on the project, due to weather. The contractors are due to re-start again in April 2023. There is approximately a month of work to complete the job, including metal etc.

Christine from Waihi Bowls is checking if Bowls will need to re-sow the greens and if so need to do this end of May. This will need to be carried out if Bowls will still be at the original Bowls site for an October start.

An update will be given at the end of April. Tanya to talk to Christine, if to re sow or not.

Bowls building can only be brought over when the greens are completed.

Fencing – Pool fencing will be around the completed Bowling Green's 1.5m high, no corrugated iron.

Bowls holds license separate Incorporated Bowls, Charitable Trust is Sport'n'Action Waihi. 1 License per park.
